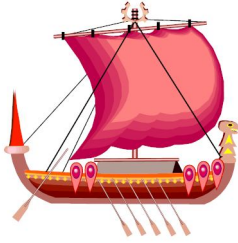

- YOU WILL RECEIVE A REGISTRATION IN YOUR NAME AND STICKERS, YOUR CAN THEN TRANSFER THESE INTO YOUR STATE AND GET A TITLE OR REGISTRATION IN YOUR STATE. THIS MUST BE DONE WITHIN 30 DAYS.
- **WHAT YOU NEED TO DO:** YOU NEED TO MAKE SURE THE VESSEL'S IS **NOT REGISTERED** IN YOUR STATE, STOLEN, OR SALVAGED. YOU MUST PROVIDE US WITH THE HULL ID #, AND IT MUST BE THE HULL ID # ON THE VESSEL. ALSO IF THERE IS A MOTOR WE NEED THE MOTOR NUMBER AND IF IT HAS 2 MOTORS, PLEASE PROVIDE BOTH AND NOTE SIDE.
- **NEW REQUIREMENTS FOR 2010: THESE CAN BE FAXED OR EMAILED, BUT MUST BE CLEAR.**
- **WE NEED A COPY OF A NOTARIZED BILL OF SALE WHERE YOU PURCHASED IT, AND CANCELED CHECK AS PROOF OF PURCHASE.**
- **COPY OF LAST REGISTRATION AND LAST REGISTRATION # ON THE BOAT AND STATE THEY ARE FROM.**
- **ONE GOOD PICTURE OF THE BOAT AND OF THE HULL ID #**
- **COPIES OF ANY CURRENT REGISTRATIONS AND PHOTO OF REGISTRATION STICKERS ON VESSEL**
- **YOU SHOULD KNOW MOST STATES INSPECT VEHICLE'S TO MAKE SURE THE HULL ID MATCHES THE TITLE.**
- **IF YOU FAIL TO DO YOUR PART AND DON'T GET A TITLE, YOU WON'T GET A REFUND EITHER. PLEASE DO YOUR PART AND CHECK ITEMS LISTED.**

TURNAROUND TIME IS ABOUT 6 WEEKS ON VEHICLES.

PLEASE DO NOT CALL AFTER A WEEK AND WANT TO KNOW WHERE YOUR PAPERWORK IS, IF YOU NEED STATUS, LEAVE A MESSAGE IN THE STATUS MAILBOX ON THE PHONE SYSTEM AND SOMEONE WILL GET BACK TO YOU IN ABOUT 3 BUSINESS DAYS. THIS INFORMATION TAKES TIME TO ACQUIRE, SO CALLING EVERY DAY WILL NOT SPEED IT UP, AND MAY SLOW IT DOWN.

- **NOTE: YOU SHOULD NOT GET HULL ID OFF OLD PAPERWORK, IT IS OFTEN WRONG. GET IT OFF THE VESSEL**
- **IF YOU'RE NOT SURE IF WE CAN HELP, PLEASE CALL AND WE WILL GLADLY HELP YOU!**
- **SPECIAL NOTE. WE ARE A SMALL COMPANY AND OUR PHONE NEVER STOPS RINGING. SO IF YOU DO NOT GET THROUGH, PLEASE LEAVE A NAME AND PHONE NUMBER, WITH A BRIEF MESSAGE AND WE WILL GET BACK TO YOU. WE GET HUNDREDS OF CALLS AND SOMETIMES IT TAKES US A DAY OR TWO TO GET BACK TO YOU. PLEASE BE PATIENT. IF YOU HAVE A COMPLAINT THERE IS A SPECIAL VOICE MAIL BOX FOR THAT. IF YOU JUST NEED MORE FORMS, YOU CAN GET THEM ONLINE OR WE ALSO HAVE A VOICE MAILBOX JUST FOR THAT, PLEASE SPEAK SLOWLY AND CLEARLY AND WE WILL GET THE FORMS RIGHT OUT TO YOU. THANKS**

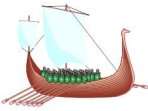
